Route 30 Lincoln Highway and Route 1 Dixie highway. I had never





guessed it we were back in the parking lot enjoying each other's company and warm night air.



From 1915 through 1920, the Dixie Highway traveled down the main street of Papineau, a tiny hamlet in northern Iroquois County, just south of the town of St. Anne and the Kankakee County border. In the early part of the twentieth century Papineau was a bustling agricultural community that boasted several grocery stores, churches, a bank, a grain elevator and a dance hall and tavern called the Coliseum. Papineau was a stop on the A's R Us Fall 2010 tour and the town looks quite different from when this photo was taken about 1920. The Dixie Highway bypassed Papineau when the highway was routed to its current alignment of the highway just west of town in late 1920.


