The Arche' Fountain was a gift to Chicago Heights from the Arche' Club of Chicago, one of the largest women's clubs in the city. Designed by sculptor George Ganiere, the fountain was dedicated on October 13, 1916 and is located on the southwest corner of the Lincoln and Dixie Highways - the "Crossroads of the Nation." From the center of the basin rises a torch, the insignia of the club, and on the lower portion of the shaft is a relief portrait of Abraham Lincoln below the inscription of the Lincoln quote: "We find ourselves in the peaceful possession of the fairest portion of the earth." The fountain, recently restored, served as a refreshing stop for motorists along the two main highways for years and was the first stop on the A's R Us 2010 fall tour.







Lets talk about some of the differences between the early 1928 Model A and

the later, 28 thru 31 Model A. Seeing as I have my engine and transmission out of my car I will use this

for our tech talk for this month.

Differences between the 28 and 29's are:

- The transmission has its parking brake located in the front of the shift lever. It was later changed to the right side.
- 28's have no front bearing retainer as 29-31's. The bell housing is used as the front retainer.
- The input shaft to the transmission has threads located on the front side, just behind the pilot-bearing stub.
- The pressure plate, clutch plate, and throw out bearing. This is a multidisc pack of plates and discs. This is a self-contained unit that is slid onto the input shaft of the transmission. Then a thick washer and nut is used to hold it. It is also cotter keyed.
- The flywheel is much bigger than the ones used later. The later are surfaced for a clutch plate surface.
  The multidisc flywheel is extended



rearward and is large enough for the multidisc clutch pack to get into it. The outside of the clutch pack is full of squared off teeth that must line up inside the flywheel. Also the throw out bearing, is part of the clutch pack. It does have it's own grease zert, which actually greases the throw out bearing. The later style only greases the front bearing retainer where the throw out bearing rides on.

The transmission gears are the same in all years of the transmission. The early 28 needs to have two thrust washers installed, one in front and one behind the cluster gear. These were later done away with when a change was made in the transmission case.

The front engine mounts on the early 28 are, an extension of the front cross member. Two flanges are higher than normal. These line up with the holes in the front of the block. This result with the engine firmly connected to the front cross member. So more of the engine vibrations are felt in this model. The later cars use a yoke type mount, that is forward of the engine and goes through the valley part of the cross member. With the use of three springs, it then has the ability to dampen engine vibrations. The rear mounts are the same thru out all years of production.

The shift tower is the same as the later ones, except for the location of the parking brake. The only other difference is, that inside of the tower, there is a thick felt


washer and a steel cover. These go onto the shift lever, and then the spring is put on just like the rest. This causes us to have to use a one-inch shorter spring. Five inches instead of the sixinch spring use since the changes were made to the single plate clutch and pressure plate used through the end of production. Now lets not to forget the little hole and the backside of our shift towers. This is a vent hole, to relieve pressure. Wouldn't hurt to check your towers and poke a wire through the hole to clean it out. Hope everyone learned something and enjoy seeing the differences.
