
# BACKFIRE



Well let me tell ya you would think that these cars hadn't been out in a while with all the fits and problems we had with numerous vehicles. I will relate my weekend with Jezebel as an unproven car on our 360-mile weekend to Holland, Michigan, in the rain, inside this addition.

Service station architecture in the 1920' and 1930's blended well into residential environments. This quaint cottage-style station was built in 1933 on the northwest corner of Ridge Road and the Dixie Highway in downtown Homewood. Shell brand oil and gas products were sold here for a few years until the station rebranded and Sinclair products were offered until 1979. Jack Kurtz, station owner for over 40 years, is pictured. A newer structure replaced this building on the site in the late 1950's.

### Proving Jezebel's road worthiness by going to Michigan

So I bought a new 1931 Tudor last October and now I am going to drive her up to Michigan on its first long distance trip in probably 20 years. I worked for a couple days pulling the wheel drums and greasing the bearings. In fact I had to replace the Rt. front bearing the night before the trip. I had asked a couple of guys in the club what they thought about the roof and they suggested to Armorall it and if I have problems later deal with it then. I stayed up until 1:00Am working on the car and felt that it should be ready to go. Friday was a beautiful day of driving with no problems



and she was running like a top. We arrived at the hotel and checked in, dropped our luggage off and then went to Ron's new home about a ½ mile away. It started out as a very nice night then rain started rolling in. We stayed in the pole barn as the storm crashed around us and deluged us with rain. After it passed thou the temperature dropped so I went to get Nancy's and my coat out of the car. I opened the car door and water poured out of the car. Well I didn't leave a window open and I found that my roof was in-fact a sponge! Ron told me to

get the car into the garage up front and we began the drying out process. Now the weatherman is calling for rain thru Monday so how will I get this car home. Friday night was a night of little sleep as I was thinking of all the possibilities to temporarily fix the roof. Randy seemed the most confidant with attaching plastic to the roof with clips on the gutters and visor, then duct tape the remainder down.

The next morning Nancy and I went into Holland with Steve in his car for the festivities and parked at a little mall that



happened to have a fabric store. We went inside and asked for table cloth material and found a PVC cloth backed material that was very thin and flexible. Well we decided that this would be our new roof. We enjoyed the day in Holland and on our way home we picked up contact adhesive and 1/4 " water pipe to make clips.



PVC material and contact adhesive along with gutter clips weatherproofed the car so I could get back home.

Saturday afternoon Randy, Steve and myself went to Ron's and installed the roof. The first coat of contact cement was sucked up into the roof. The second worked like a charm. Randy made clips and Steve helped install the roof. We pulled it tight and it hugged the roof. The cement held tight and the clips insured air couldn't get under it. We decided to pick the car up Sunday morning for the drive home.



Sunday was raining and as you can see in the picture the water beading on the roof. This is where we have more fun with the car. Nancy and I drove to breakfast after push starting the car at Ron's house. We came out after eating and she wouldn't start. So numerous club members pushed the car and we couldn't get her started. Claude towed us to the hotel where I popped the clutch in the parking lot as we arrived back and she put on a show! I'm in the car doing everything in my power to keep her going and she was firing volleys of backfires the likes I've never herd before, then she died. Well Jon gave it his all under the awning and we finely decided to tow her back to Ron's pole barn to get out of the weather.

It was decided to get 15 of the Model A's on the road home while Jon, Randy, Herman and myself stayed and worked on getting Jezebel back to life. Nancy, Yvonne and Bonny took refuge in the house at one time even turning the lights out on us as they figured out how to start the well pump for water in the house.

We knew that my battery was dead so we took Ron's battery from his car that he was leaving up there. Then the team started tracing the electric problem by changing parts out and checking for dead shorts. We were getting no spark at the distributor. A little over an  $1\frac{1}{2}$  hours later Jezebel sprung back to life! Seems that with the new parts in the distributor we had a bad set of points.

We took off thru the rain almost 2 hours behind the others going down the Blue Star Highway and then on the Red Arrow checking in with the other group by phone occasionally. We were going to meet in Michigan City for lunch. We pulled in  $\frac{1}{2}$  hour behind them as their route took them father East of the lake than did our route.

All I can say is it's always easer being on the giving end of help rather than the receiving end. Thank you to everyone in the club for their help. It was still a fun weekend!


