## <u>Shake down soon....</u>



there's a open hood your sure to find a couple guys willing to fix it.






Early in the motor age, spare automobile wheels were made to clamp on the existing wheel and rim of a car when a puncture or other problem caused a tire to go flat. The Stepney Spare Automobile Wheel originated in Wales and the company had an American subsidiary which produced spare auto wheels in St. Anne just off the Dixie Highway from 1908 through the late teens. The company slogan was "On and Gone in Less than a Minute." There was no need to change the damaged tire, saving stress, annoyance and the loss of valuable time. There also was no special equipment or tools of any kind required to affix the wheel because it was secured by simple thumbscrews and the Stepney spare was always carried fully inflated and ready for use. By the late teens, as automakers began to supply their own spare tires with the cars they made, the Stepney company's business declined and the U.S. affiliate closed. The factory was later sold and became the St. Anne Foundry.

Well anyway, a couple days later Jon Lisota and myself drove up to Highland Park with trailer in tow to pick-up the car. When we got there the car was outside and Mr. Curtis was standing there waiting for us.



As I went in to do paperwork I turned around and all that were seen



were Jon's feet from under the car. When I returned Jon was finishing up so I stuck my head by him to see if the car was ready for the trip and we both herd the same noise. Click, Click, Click as the engine was running. We turned the motor off and found a cracked fan blade ready to

ram thru the radiator or hood. Mr. Curtis thought we were nuts to drive the car home anyway. Jon looked at me and said "Jezebel"

going on the trailer home. I said that's fine but will we have room after we put the car on trailer? "Jezebel is the car" Jon said she told me so! I wasn't going to ask; so we loaded the car, and two milk cans on the trailer. and a 1938 Gilbarco pump in the Explorer. We arrived home unloaded the car and drove it into the garage. Nancy was guite pleased with the car but she was in for a surprise as I was going to dismantle the car in a couple days.



After I had taken the engine down to the short block I found that not only did I have a cracked original fan blade but also the timing gear was missing 16 teeth!



owner had put in, and corrected misswiring that had been done. Re-placement of shorted headlight sockets and finally I have lights. Sometime you wonder how the car ran to begin with. On the starter I installed a new switch. A new AMP meter and stoplight switch, and firewall junction box. All the refurbished parts and gaskets were lined up for re-assembly. Jon came over to check out and reassemble the engine and in a few hours she was running like a top. Jon had me



Here is another disaster that could have happened on the road. There was a <sup>1</sup>/<sub>2</sub> inch of sludge in the oil pan and the top end was carboned up. I scraped and steel wool the valves and piston heads. I cleaned; bead blasted, and repainted all the parts. I ran a coat hanger and air blasted the water jacket on the block getting all sorts of rust out. I had the radiator cleaned and pressure tested and scraped and painted the frame and firewall. I pulled the extra wiring a previous



put a stocking in the top hose to catch the rust that I loosened up. I've changed this 4 times now and it seems like its almost gone. Soon I will have it on the road to shake out any other bugs Jon or I may have missed and I hope to drive it to Holland MI on the spring trip.
