For years Steger was known as the piano capital of the world. Once piano manufacturing waned in the village, making macaroni gained prominence in one of the old piano plants. In 1930, the D'Amico Macaroni Company moved from Chicago Heights to the former Reed piano factory building located on the southeast corner of 35th and Chicago Road. Established in 1913, D'Amico sold product under the *Mamma Mia* brand. A new plant was built in 1970 a block south at 3601 Chicago Road. The old plant was destroyed by a fire in 1974 and a Shell gas station now occupies the site. Gooch Foods Inc. later purchased the company, but by 2003, the plant was closed and its equipment sold at auction.

As we wait for spring to arrive we are planning our shakedown cruse. This year we are going to Cantigny Park. Cantigny Park is located in Wheaton, Ill. (35 mile away). This sprawling, 500-acre park is where families wander through nature and get lost in history, In addition to vast formal gardens and picnic and camping grounds, Cantigny offers two history-rich museums: the Robert R. McCormick Museum and the Cantigny First Division Museum. So who was Robert R. McCormick? He lived from 1880-1955. He is best known as the editor and publisher of the Chicago Tribune for 44 years. He built the Tribune Company from a single newspaper to a media giant by creating radio and television stations and building newsprint factories.

This one-time politician became a citizen-soldier, serving in the Illinois National Guard in 1915, and a Colonel in the First Infantry Division during World War I.

He enjoyed the life of a gentleman-farmer, operating the Tribune Experimental Farms in Wheaton and Yorkville, Illinois and influenced the creation of Meigs Field, an airport

Illinois Club prepares for road Emergency

The A'S R US Chicago Southland club had a very different meeting in January to say the least. While different, the meeting will probably be one of the most important our members have ever attended.

Like most clubs, ours has a tendency to "get away from it all" and travel far from civilization on our road trips. With most members on the downside of the halfcentury mark, this can create a problem particularly if medical treatment is ever needed. For years we simply ignored the problem until a few minor issues forced us to think more seriously about what we would do if one of our members had a cardiac event or some other serious

medical incident in the "middle of nowhere." In most cases trained medical help could be more than 10 to 20 minutes away, which could be too long a period of time to be of any benefit in a real emergency.

As a certified Firefighter EMT-B in the state of Illinois, I have thought about this for some time and decided to do something. While we do have a retired paramedic and a couple of nurses in our club, we had no equipment for them to provide adequate care and I wanted to be prepared. Who knows I could be the one in need rather than the one to provide the help! Through contacts in the medical field, I was able to come up with an economically

priced AED (Automatic External defibrillator). In November, I presented this proposition to our club and the motion to purchase this piece of equipment passed unanimously.

Our January meeting was held at my house and it was a time to teach our members the skills to use the AED. Vince Penna from "Defib Solutions" in Crown Point, Indiana gave us the great deal on our AED and also offered his time and expertise to teach our club how to use the AED and how to perform CPR to be effective in the event we ever have to use this equipment.



The meeting night started ½ hour earlier than normal and we got directly into our program with Vince teaching American Heart Association CPR and AED usage. He was quite a good teacher using stories and funny anecdotes to keep everyone involved and focused on the new skill sets he was teaching. In no time, he had our members performing CPR to the tune of "Staying Alive" on "Preston" manikins. These are state of the art and have LED lights built in that let you know you are keeping to the recommended 100 beats per minute. After this workout that had its humorous moments, he introduced us to our new Cardiac Science G3 AED. Vince explained placement of pads and how to follow the

prompts that the unit will give us in an emergency.

We learned a lot that evening and, most importantly, we learned the quicker you defibrillate a victim the greater the chances of survival. A victim's chances of survival are reduced by 7 to 10 percent with every minute that passes without CPR and defibrillation. Few attempts at resuscitation succeed after 10 minutes. We have bettered our odds with our purchase and

you may want to better yours too.

For years I have kept a small tackle box with some basic first aid supplies. Now I have put together a Basic Life Support bag with airways, ambo bag, prep kit and our Cardiac Science G3 AED. We also will carry a glucose meter, blood pressure cuff, stethoscope, baby aspirin,

Benadryl, antibiotic cream, sterile water, basic dressings and the allimportant Band-Aid.

In short the AED is an insurance policy that I hope we never have to use but if we need to, our club members will have the confidence to render quality aid when and wherever we may travel.




Demonstration of the G3 AED


