#### FALL TRIP – 2012 SOUTH BEND, INDIANA

Ever heard someone say, "You just don't know what you're missing". We knew what we were missing; we just couldn't allow ourselves to consciously admit how deeply. That was the discussion Joe and I had all weekend long. This trip was not supposed to happen for us but here we were, back with friends, who are like family, and Bob, Penny and Betsy, our actual family. It really surfaced as we were riding with Tim Dionne to the thirty-eight-room J.D. Oliver Mansion. Everyone apparently had slept well the night before and all were well rested. The excited chatter on the radios was non-stop. Joe, Tim and I were laughing because it sounded like all the fourteen year olds in the area had been let loose in their first cars. It happened again on the way to dinner at the Studebaker Mansion later that evening when everyone went in different directions. We actually split into three groups on three different streets. That's usually referred to as a Chinese Fire Drill or Keystone Cop move. Now for the rest of the story....

We all met for breakfast at the Egg & I in Chicago Heights. Twenty-plus cars arrived on a particularly beautiful Friday morning. Ron Bonneau stopped by to wish us well on our trip even though he couldn't join us. Connie & Tim Borchert brought friends Jo and Mike with them. Nancy Serviss also brought her friend Mary. This was a first Model A outing for them. I'm sure it was the first time for a lot of in and out of a car and unexpected events. It's always fun to see new people experience what we all know as organized mayhem.

Heading out on Route 30 we made our way to the Dyer, IN Historical Society and their Lincoln Highway Exhibit. We learned about the early 1830 settlers and Dyer's impact on the growth of Northwest Indiana.

Deep River Mill and Park was our next destination in Lake County, IN. We were able to see a demonstration of how a gristmill actually works. We heard the history of this particular mill built in 1837 and the flood that destroyed it. Parts were rebuilt later but, the mill actually fell unused in the 1930's. The mill was eventually purchased by the Lake County Parks and is now on the National Register of Historic Places. We all had a chance to watch corn milled and time to visit the gift shop, which was, at one time, a 1904 church. There were very nice handcrafted goods to purchase, especially the freshly ground corn and all kinds of jams and preserves.



The country roads we traveled heading toward Plymouth, IN were exceptional, to say the least. In addition to well-paved roads we were treated to nature's unending Fall show of color. There were the most vibrant yellows, pungent burgundy, flaming vibrant reds, with still an abundance of greens, browns and beige. How fortunate we are to see such wonders riding along in equally amazing little automobiles, which also range in color. We actually have several greens, a red, a butterscotch gold, a gray, a couple of taupe and brown tones, couple of hints of blue and black. We put on a pretty fair show ourselves. If you ride in the back of the line you really get the full effect.

In Plymouth, we had lunch at the Brass Rail Restaurant and added a little time for shopping. Joe took a little snooze on the back seat of Bob's car. Well, at least until people started looking in the window and saw him, exclaiming, "there's a man sleeping in there". Joe replied, "No, I'm not", then proceeded to answer questions about Bob's car. I went to sit in our car and decided to call the Ivy Court Inn and see if they had any cancellations. We were supposed to spend Friday at the Residence Inn. Viola! They were able to give us a room. That helped a lot because then Joe and I didn't have to unpack twice. Just trying to save the man some unnecessary use of energy. Great accommodations! More about that later.



Onward toward South Bend! Arriving in Donaldson, IN we were privileged to visit the Ancilla Domini Chapel, which means Handmaid of The Lord. It is the Ministry Center for the order Poor Handmaids of Jesus Christ. The German baroque stained glass windows add to the beauty of this huge chapel that is almost 150 feet from the door to the altar. The ceilings rise 60 feet high and the building is about the same in width. Even the colors within the chapel are shades of gray to create a vision of incense burning. Green-gray for hope; purple-gray for sorrow; and rose-gray for joy. A lovely and peaceful place. Without telling the other, Joe and I both gave thanks for the miracle of this trip.

More beautiful roads and we arrive at our destination. Tired, somewhat hungry but satisfied that the day had gone well. We had cold cuts, potato salad and, copious quantities of dessert, much of it home made. We probably had the single largest variety of liquid refreshment in many many trips. You couldn't have gone to the local bar and had that much variety! Almost. Accommodations at the Ivy Court were better than most of us expected. We had the whole room to ourselves and really appreciated the opportunity to just sit, relax and mull over the events of the day. It's hard to spend time with everyone but I believe we all did our best to spend a little time with each other. Hopefully we made our new friends feel welcomed. It is said that several people had a wonderful night's sleep due to Chuck Fritz' Moonshine. Hmmmm.

Breakfast at Ivy Court was so good. Crisp bacon, eggs, yogurt, waffles, pancakes served banquet style. It helped us get ready for the day. Off to the Studebaker National Museum and Copshaholm, the home of J. D. Oliver and his family. It is one of three historic houses owned by the Center for History. We first visited The Worker's Home decorated in typical 1930's style. Amazing how many of us recalled the feeling of that house and many of the contents within. The flip toaster, the claw foot tub in the bathroom, the relatively small rooms. I felt like I was back at my grandmother's house. I remember using that flip toaster and thinking that's pretty nice. Our toaster at home only popped up. Boring.

I have to say the thirty-eight room Copshaholm mansion was beyond description. It outshone most of previous mansions we've toured. They were cottages compared to this home. I'm not even going to describe it other than to say it was three floors of jaw dropping ambiance and furnishings. Walking up and down three flights of stairs was good exercise but a challenge for some. Our docent was knowledgeable and gave us great insight into the family and the family oriented patriarch who built it. A tour of the carriage house was the last stop. Again, it must have been quite a site to see the stables, carriages



and wagons back in the day. We walked over to the Studebaker Museum and viewed the beautiful historic cars and many of the exhibits provided for the public.



Finally it was then time to walk over to the parking area where Chuck Fritz and the Chuck Wagon were in full operation. We had a lunch of burgers, brats, chicken, coleslaw, potato salad, and again more and more desserts. We sat around viewing the beautiful grounds in the warm sunlight. Once again we were blessed with a perfectly beautiful Fall day. Part of the group went on to tour the beautiful Notre Dame University campus. Some of the group had the opportunity to attend Mass at the Notre Dame Basilica. Time for a rest and then off to dinner at Tippecanoe. This was the residence of Clement Studebaker. The mansion was built in 1889. We had dinner on the top floor of the former mansion of forty rooms and approximately 24,000 square feet. After dinner we returned to the group room at Ivy Court. Saturday night happened to be the Fall Harvest Moon. Yes, a few of us actually stood in the parking lot and sang "Shine on Harvest Moon" and remembered the words. Hmmm, old.

Sunday morning was again beautiful and sunny. We had a good breakfast at the Inn, gathered our suitcases, packed the cars and were once again on the 1913 alignment of the Lincoln Highway. Our destination was New Carlisle. This was land once occupied by the Pottawatomie Indians until 1826. Today about 1900 residents occupy the town. The attraction here is a magnificent house called Old Republic near Hudson Lake. It is actually the Jeremiah Service House known as Old Republic. Yes, there is a connection between this person named Service and our own Phil and his dad, Russ Serviss.

Next stop was a visit to a dance hall on Hudson Lake called Hudson Lake Casino. Built in the 1920's and still in use to this day. This was a little longer stop than planned because the "Vickie" refused to leave. Eventually

persuaded, the car purred along and we were off to Valparaiso. We had lunch at the Industrial Revolution Restaurant



and just relaxed recounting the entire trip and how much fun we all enjoyed. We had our usual hugs and goodbye ritual that is always an important part of the trip. One group headed south and the remaining group headed west and north. The radios began to crackle losing transmission as we traveled. We heard, "your tire is going flat". Just couldn't end the trip without a tire going flat. What a wonderful weekend it was. It was just the medicine Joe and I needed.
