

Tiny Wichert, just north of St. Anne, was once located on the original alignment of the Dixie Highway (1915-1920). Today, the sleepy hamlet lies just east of the current alignment of the Dixie Highway. This area became known as Wichert, after Henry Wichert who started a pickle business there that was later taken over by C.F. Claussen & Sons. The Bonvallet family began growing asparagus in Wichert in 1871, which led to commercial production, followed by experiments in canning. A canning factory was established around 1897, which was unique in the Midwest. They grew white asparagus and canned individual size portions for railroads and hotels, along with eleven other varieties. They employed 30-40 cutters and canned the asparagus within two hours of picking. White asparagus was obtained by cutting the stalks underground just as the tips began to break the soil.




Their product was renowned for quality and their gold embossed label helped promote that reputation. The company later canned tomatoes and other products. In its later years, P.A. Bonvallet Sons sold gardening supplies and the company closed in the early 2000's. Today vegetables like potatoes, cabbage, peppers, squash and pumpkins are still grown in abundance in the area.

1920's FUN AT THE BEACH: In the early 1920's fun at the beach and actually getting into the water to swim was a new concept. Functionality in swim wear was not as important as fashion, so the theory was that wool would keep you warm.


Women wore a swim dress which consisted of a longer skirt over attached shorts. The beach police patrolled the beaches with measuring tapes in hand. They would measure the distance from the bottom of the woman's bathing skirt to her knee. Too much bare skin resulted in a hefty \$10.00 or sometimes even jail.

By the mid 20's women actually wanted to swim rather than splash and wade in the water. In 1926 the two piece, nonskirted, swimsuit made its debut for men and women. Jantzen created a very popular suit that looked like it was two pieces resembling a tank top, on top of a pair of swim trunks. Necklines dropped to deep boat or V necks, arm holes grew bigger to make swimming easier and colors were vibrant red, blue, black, gray and Kelly green. This suit was still modestly worn only a few inches above the knee and sometimes worn with black stockings rolled down to above the knee with swim choes. Now that women were actually swimming a swim cap in an aviator style, helped keep their bobbed hair from losing shape.




1822 Beach Police Modesty Check





in the mid 1920's MENS swimwear also became more Functional and also showed off their newly athletic bodies. In many ways men's and women's early suits were nearly identical, wool and skirted. . For men 1926 brought a deep cut ribbed wool tank over a pair of snug fitting shorts, mid thigh length. The tops were often white or stripped and the trunks a dark color. Athletic swimmers were the first to brave these skimpy suits.




